# MSc in Finance

## PROGRAMME OVERVIEW

The Master's Programme in Finance prepares you for an international career in the financial services sector, e.g. in commercial and investment banking, insurance firms and supervisory authorities, and in finance functions in both private and public sectors. Graduates from this programme have found work at financial and nonfinancial companies all over the world.

The programme extends your knowledge of all major areas of financial decision-making. You will gain a thorough understanding of, and training in, effective identification, analysis and resolution of complex financial problems. The programme is research-driven and based on the principle of academic rigour in practical application. You will learn advanced theoretical and empirical concepts in both financial economics and corporate finance.

Important objectives are to familiarise students with the main areas of investigation and research techniques used in finance, and to give you the general knowledge required to specialise in your preferred area of finance. As a MSc Finance student, you have access to extensive data resources, including Bloomberg terminals. You will be able to view live market data from across the world and use it to test how theoretical mathematical financial models stand up in practice.

The School's Career Services provides you with opportunities to gain the skills you need to compete for international jobs in finance. As part of your orientation week, a half-day career workshop is run, especially tailored for the students of the MSc in Finance. With a Master's in Finance from a world-class university, you are well-equipped to pursue a career in finance all over the world.

## TOP 50 IN THE FINANCIAL TIMES RANKING

The Finance programme is ranked in the Financial Times' prestigious global ranking of the best Master's in Finance. The international financial paper sends questionnaires to the students who graduated three years ago, in which they have an opportunity to answer questions about what the study programme has meant for them, how their careers have taken off, what they have learned, to what extent they feel their studies paid off, etc.

## DOUBLE DEGREE OPTIONS

For students that deliver very good study results during the initial semester of the programme, double degree options with EM Lyon and University of Groningen will be offered.

## PROGRAMME MODULES/COURSES

In this high speed, high learning programme you will gain solid knowledge in the broad finance area.

### Courses and number of credits

Foundations of Finance (7.5); Financial Econometrics and Machine Learning (7.5); Theory of Corporate Finance (7.5); Empirical Finance (7.5); Managerial Finance (7.5); Financial Valuation and Risk Management (7.5). At the end of the year, you apply your new skills and knowledge set by completing a degree project of 15 credits.

## CAREER PROSPECTS

This is a programme for students who are aiming for a career in the finance industry, including portfolio management, investment banking, trading, security analysis and asset allocation. Financial skills are also in demand by regulators and policy makers in the area of financial markets. The programme also prepares you for PhD studies in finance.

Graduates have found work at financial and nonfinancial companies such as Credit Suisse, Citco Group, Goldman Sachs, Royal Bank of Scotland, JP Morgan, BNP Paribas, China Investment Corporation, Standard and Poor's, Maersk, PwC, Electrolux, Tetra Pak, L'Oréal and Volvo.

## ENTRY REQUIREMENTS AND HOW TO APPLY

### Entry requirements

An undergraduate degree (BA/BSc) and at least 90 ECTS credits in business administration and/or economics. These must include a course in basic microeconomics (which can be a part of a course in basic economics), a course in intermediate finance and a course in econometrics or statistics. English Level 6.

### How to apply

Click on "Apply" and follow the instructions for the online application at [www.universityadmissions.se](http://www.universityadmissions.se), the Swedish national application website. Rank the chosen programmes in order of preference.
2. **Submit your supporting documents:**
  - **General documents:** Check what documents you need to submit (i.e. official transcripts, degree diploma/proof of expected graduation, translations, proof of English, passport) and how you need to submit them at [www.universityadmissions.se](http://www.universityadmissions.se).





- **Programme specific documents:** When applying for the MSc in Finance, we do not require a GMAT or GRE score but a well-balanced score may strengthen your application to this particular programme. GMAT code, School of Economics and Management, Lund University: 8VR-PL-07. Lund University does not have a GRE code. You are welcome to submit a certified copy of your GRE test result directly to University Admissions in Sweden.

### 3. Pay the application fee (when applicable).

#### Selection criteria/additional info

Selection is based on academic merits from university studies. In the assessment, special weight will be given to grades on courses that prepare students for the curriculum of this study programme.

#### Tuition fees

Tuition fee SEK 145 000 per year for non-EU/EEA citizens. No fee for EU/EEA citizens. See [www.lunduniversity.lu.se](http://www.lunduniversity.lu.se) for details on tuition fees.
